Dear Professor Shaw:

At its April 18-19, 2025, meeting, the Board of Directors of the National Architectural Accrediting Board (NAAB) reviewed the Plan to Correct submitted by the Master of Architecture degree (undergraduate architecture degree + 69 graduate credit hours; undergraduate non-architecture degree + 111 graduate credit hours) at Rhode Island School of Design and voted to defer action and require a revised Plan to Correct to address all remaining areas of non-compliance.

The Board noted that the program submitted sufficient evidence to demonstrate compliance with the following Conditions for Accreditation previously noted as “not met”:

- 5.1 Structure and Governance
- 6.6 Student Financial Information

The Board noted that the program did not submit sufficient evidence to demonstrate compliance with the following Conditions:

- 5.6 Physical Resources

The Board’s review is included below:

5.1 Structure and Governance

The program must describe the administrative and governance processes that provide for organizational continuity, clarity, and fairness and allow for improvement and change.

- 5.6.3 Space to support and encourage the full range of faculty roles and responsibilities, including preparation for teaching, research, mentoring, and student advising.
- 5.6.4 Resources to support all learning formats and pedagogies in use by the program.
- 5.6.5 Plans for disaster and recovery of information.

If the program's pedagogy does not require some or all of the above physical resources, the program must describe the effect (if any) that online, off-site, or hybrid formats have on digital and physical resources.

Not Met. *The program did not provide sufficient information to meet the requirements of this Condition. The program needs to provide evidence of completed improvements to the physical resources.*

The program is required to submit a Plan to Correct demonstrating compliance with the Condition noted as "not met," by **December 15, 2025**.
